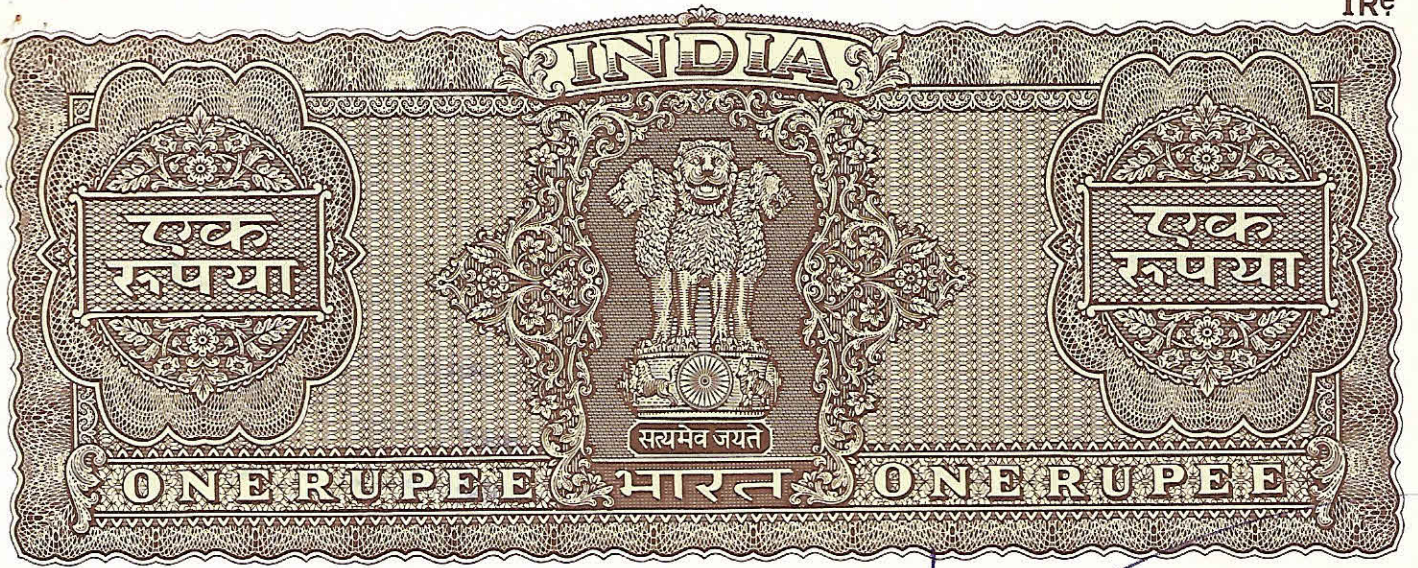

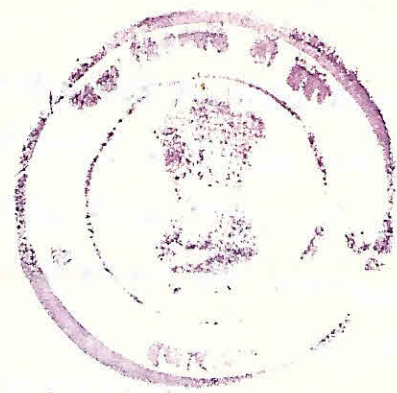

After depaying all necessary expenses in the proper- UP-KEEP and management of the Trust, all the schools in/under the management of the trust, the balance of the income shall be deposited in a scheduled Bank preferably state Bank of India under savings Account.

All the internal administration of the Trust and of the schools will be governed by the Bye-laws to be framed by the Trustees in a meeting and may be amended from time to time, if necessary by General Meeting of the trustees.

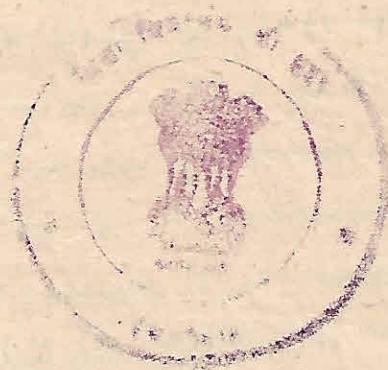
